Dear Reader,

The University of Missouri-Columbia is committed to providing the members of the campus community and visitors with the safest and most secure environment possible; however, even the most extensive initiatives cannot succeed without the awareness and cooperation of the community members who work, study and live on campus.

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act required all postsecondary institutions participating in Title IV student financial aid programs to disclose campus crime statistics and security information. The act was amended in 1992, 1998, 2000, and 2008. The 1998 amendments renamed the law the *Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act* in memory of a student who was slain in her dorm room in 1986.

The *Clery Act* requires higher education institutions to give timely warnings of crimes that represent a threat to the safety of students or employees, and to make public their campus security policies. It also requires that crime data is collected, reported and disseminated to the campus community and are also submitted to the Department of Education. The act is intended to provide students and their families, as higher education consumers, with accurate, complete and timely information about safety on campus so that they can make informed decisions.

In compliance with this act, the University of Missouri-Columbia Police Department has produced this report, "Campus Safety & Crime Report", which contains the aforementioned information. In addition to campus crime statistics, this report is also a resource guide for campus safety services and crime prevention strategies. The University of Missouri Police Department and the university community envision a future in which all members enjoy an enhanced quality of life and a reduction of crime, social disorder and fear of crime.

We will strive for excellence and become a benchmark in the provision of innovative, professional and quality police services. We will utilize education, training, and advanced technology for employee development and become proficient in problem solving and conflict resolution.

We will heighten our profile as an integral part of the university community, widely respected and trusted by its people.

Our shared vision is reflected in our value statements and mission statement that serves to guide us in our daily operations and conduct. These beliefs guide us in our strategic planning process of establishing goals, objectives and strategies.

The University of Missouri at Columbia Police Department is a fully commissioned police department that works very closely with Federal, State, and Local Law Enforcement agencies to provide proactive law enforcement services to the MU campus. Commissioned police force means that the officers at MUPD have the same arrest powers as your local police department and that of the City of Columbia.



On March 24, 2001 the University of Missouri at Columbia Police Department (MUPD) was awarded accreditation by the Commission on Accreditation for Law Enforcement Agencies (CALEA). MUPD was the second Big 12 School to accomplish this along with Iowa State University. MUPD has now been re-accredited by CALEA twice, most recently on 11/18/06.

The first International Association of Campus Law Enforcement Executives Association (IACLEA) Accreditation awards were presented to five member agencies during the Opening General Session of the Annual Conference in Las Vegas, NV on June 26<sup>th</sup>, 2007. IACLEA Accreditation Commission Chair, Dolores Stafford, presented the awards to the University of Missouri (Columbia) Police Department, the University of North Texas Police Department, the University of Richmond Police Department, the San Francisco State University Police Department, and the George Washington University Police Department. Each of the five agencies, previously accredited by the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA), voluntarily elected to pursue IACLEA Accreditation through an accelerated process of "comparative compliance".

In commending the accredited departments, newly installed IACLEA President, Ray Throver stated, "Recent events have demonstrated the need for campus public safety agencies to hire and train capable personnel, to provide them with clearly written operational guidelines, to periodically evaluate their performance, and to continually assess administrative and operational processes. The IACLEA Accreditation Program provides the framework to accomplish these things. The five agencies accredited in Las Vegas distinguished themselves, first by achieving national accreditation through CALEA and then by attaining the "Gold Standard" of IACLEA Accreditation. Their participation in the accreditation process represents a commitment to the highest professional practices in campus public safety management, administration, operations, and support services."

### **Annual Campus Security Report**

The University of Missouri Police Department has the role of gathering information for, preparation of, and submission of the institution's Annual Campus Security Report. The annual campus security report is reviewed and updated annually as one cohesive document per the requirements of federal law. It shall be the duty of the University of Missouri Police Departments Support Services Commander, or their designee, to gather the required information for and submit the institution's Annual Campus Security Report prior to set deadlines.

### **Daily Crime Log**

The University of Missouri Police Department maintains a written, easily understood Daily Crime Log that records, by the date the crime was reported, any crime that occurred on campus, on a non-campus building or property, on public property, or within the established jurisdiction of the campus and was reported to the department where an official police report was taken. This log includes: the nature, date, time, and general location of each crime, and the disposition of the complaint, if known. This log will not include reports made to other agencies. It shall be the duty of University of Missouri Police Record's personnel or Communications personnel to prepare this report in a timely manner so the community and media have access to the information.

### **Timely Warnings**

The University of Missouri Police Department shall provide timely warnings about reported crimes to the campus community, in a manner that will aid in the prevention of similar crimes if it is determined that a threat exists. Departmental supervisors shall review all reports taken by the department in a timely manner to determine any offenses that are subject to disclosure in the Annual Campus Security Report and represent a threat to faculty, staff, and students of the campus community. If it is determined that there is a threat, the supervisor, or their designee shall notify the public information officer, or their designee who will send out a media release, mass e-mail, and/or do a web posting of the incident to help prevent similar crimes from happening.

### **Annual Emergency Notification Test**

As part of MU's ongoing emergency preparedness program, MU conducted a test of the MU Alert Emergency Notification System on the afternoon of Monday, November 10th. The test focused on the text messaging and e-mail capabilities of the system. Only those members of the campus community who have provided a text messaging number received a text message during the test. However, all faculty, staff, and students did receive an e-mail from the system. ## **Crime Reporting**

The University of Missouri Police Department is the primary agency for reporting and investigating all crimes that occur on University of Missouri property. Any instances of criminal or suspicious acts and emergencies occurring on the campus of the University of Missouri, including residence halls, should be reported to the University of Missouri Police Department (MUPD) regardless of how seemingly insignificant the crime.

MUPD can be contacted by telephone, emergency phones, in person, by e-mail, and via the world wide web. The non-emergency phone numbers is 882-7201, and if it is an emergency simply dial 911. If dialing 911, the initial call will go to the City of Columbia Joint Communications to determine if medical assistance is needed. Joint Communications has direct dispatching access to medical and fire personnel. This speeds up the process of dispatching an ambulance. If the 911 call is police related, the call and all information will be transferred immediately to MUPD via a specially designated phone and computer line. Emergency phones are located across campus and are directly linked to the MUPD Communications Center. If you see an MUPD officer in a vehicle, on foot or on bicycle, get their attention and they will assist you.

Officers will respond as quickly as possible to any request for assistance, whether it is an emergency or not. Response time is based on current activity load and the urgency of the call. Crimes in progress, traffic accidents and medical emergencies have a higher priority than other types of calls. A police officer will meet with you to gather information and prepare an official report. That report may then be forwarded to the Investigation Unit, where a detective reviews the report and evidence (if any) to attempt to determine the cause and perpetrator(s) of the crime.

In all instances of criminal activity, the University Police Department works to determine the exact nature and perpetrator(s) of the crime for the purposes of developing a viable case to be forwarded to the City of Columbia Prosecutor's Office or the Boone County Prosecutor's Office for prosecution. In some cases offense reports will also be forwarded to the Division of Student Affairs for adjudication through the campus disciplinary process. Statistics for cases forwarded to Student Affairs that are offenses pursuant to The Clery Act will appear in this report.

MUPD maintains a close working relationship with local, state and federal law enforcement agencies to include the Columbia Police Department, Boone County Sheriffs Department, Missouri State Highway Patrol, and the Federal Bureau of Investigation. MUPD also has signed memorandums of understandings with the Columbia Police Department and the Missouri State Highway Patrol.

MUPD also shares information with other police agencies nationwide through memberships in a wide network of organizations. This information sharing is used for criminal prosecutions and crime prevention techniques.

Every month MUPD reports its Uniform Crime Report to the Missouri State Highway Patrol for inclusion of crime statistics that is published by the Federal Bureau of Investigation.

### **Voluntary Confidential Reporting System**

The University does not have a voluntary confidential reporting system for annual crime statistics. There are some very good reasons, in addition to prosecuting criminal activity, to promptly report crime.

- ◆ Timely notification about certain types of crime may affect the safety of others. These crimes include murder, rape, sexual assault, burglary, robbery, motor vehicle theft and arson.
- ◆ When you make your report, you assist MUPD in maintaining accurate records of the incidence of crime on campus. This information helps to keep the campus safe by providing the most accurate information on criminal activity to members of the campus community.

### **Reporting Procedures**

#### **"Is This an Emergency?"**

When you call the police to report a crime, the dispatcher will ask you the question above. For your safety, be prepared to answer all the questions the dispatcher asks you, and be specific. Don't downplay the importance of your call. Here are points to immediately consider when reporting a crime:



- ◆ Is anyone's life or safety threatened?
- ◆ Does anyone need medical assistance or an ambulance?
- ◆ Is the suspect(s) still there? (If so, make sure the dispatcher knows this.)
- ◆ Does the suspect(s) have a weapon?

Crimes in progress, or those involving life-threatening circumstances, receive the highest priority response. If the crime is still in progress, do what you can to ensure your own safety first. If you are outside your home, get to a public area - an open store, a restaurant or other public area. If at home, residence hall, or apartment, go to a safe area of the house, or go outside.

### **Information Police Will Want to Know When You Call**

#### Where:

Where are you now?

Where did the crime happen?

If the suspect(s) are gone, where did they go? In what direction?

Did they use a car or some other transportation? Did you get the license number?

What:

What exactly happened or is happening? Describe the situation in complete detail. (e.g., "Someone has just broken my window and is inside my apartment")

What are the suspect(s) physical characteristics? (sex, height, weight, hair color, race. etc.)

What was the suspect wearing? (distinctive colors or clothing)

When:

When did the crime happen? Is it still in progress? (This is very important, as it may determine the level of response.)

Who:

Who are you? What phone number are you calling from?

Don't hang up the phone until the dispatcher tells you to do so. You may be put on hold while the dispatcher contacts emergency responders.

### **Rape and Sexual Assault Procedures**

The University of Missouri does not have a rape and sexual assault policy but does provide the following procedures:

If you are a victim of a sexual assault you should do the following immediately after the assault:

1. Call the University Police Department, 911 or (573) 882-7201. If the sexual assault occurred off campus, the victim may still call MUPD. If the victim chooses, MUPD will notify the appropriate agency to handle the report.
2. Seek medical attention in an emergency room or other medical provider that performs legal rape exams.

- Friend/Relative

If you choose to call the University Police as one of your options, and if you choose to file a report of the incident, the following information will be discussed with you.

- A. Remember that YOU are a victim. You have nothing to feel guilty or ashamed about.
- B. A police officer will contact you at the scene of the attack, the hospital, or another location.
- C. To preserve evidence, you should not bathe or change clothes or do any cleaning up in any manner prior to receiving medical assistance.
- D. You are the person in control when you contact the police department and you decide how you want the incident handled.
  - ◆ You may press charges against the suspect.
  - ◆ You may ask that University disciplinary action be initiated against the suspect.
  - ◆ You may ask the police to contact the suspect about the incident, and still choose not to have the suspect arrested.
  - ◆ You may tell the police not to contact the suspect about the incident, and still choose not to have the suspect arrested.

It is not required that you press charges against the suspect, but the police hope that you will proceed with prosecution. Then, your assailant may be arrested for what they have done to you. However, IT IS YOUR CHOICE.

You may also choose to proceed through the University Discipline Procedure in addition to, or in lieu of, pressing criminal charges against the suspect. The University Discipline Procedure provides that in cases of alleged sexual assault:

- A. The accused is subject to University sanctions which may include probation, suspension from the University for a specified time, or permanent expulsion from the University.
- B. The accuser and the accused are entitled to the same opportunities to have others present during a campus disciplinary proceeding.
- C. The accuser and the accused shall be informed of the outcome of any campus disciplinary proceeding which alleges a sexual assault.

The University of Missouri can enforce sanctions for rape and other sex offenses to include from the minimum of disciplinary probation to the maximum of expulsion.

Requests for assistance in changing your academic or living situation may be directed to the Vice Chancellor for Student Affairs or the Coordinator of the Women's Center.

## **Rape Awareness**

The Women's Center conducts several educational seminars throughout the year to raise awareness for issues of sexual assault and rape on campus. The Crime Prevention Unit attends meetings to help plan for Rape Awareness Month held every September. The University of Missouri at Columbia Police Department spends several hours training the Rape Education peers on the legal process involved with reporting a sexual assault or a rape.

### **Campus Sex Crimes Prevention Act Information Provided by S. Daniel Carter Senior Vice President, Security On Campus, Inc. 2003**

The Wetterling act is named after Jacob Wetterling, age 11, abducted by a masked man at gunpoint near his home in St. Joseph, MN. The law mandates that each state create a very narrowly drawn specific program to register sex offenders. (Federal, enacted 1994)

The *Campus Sex Crimes Prevention Act* (section 1601 of Public Law 106-386) was enacted on October 28, 2000 and provides for the tracking of convicted, registered sex offenders enrolled as students at institutions of higher education, or working or volunteering on campus. It was sponsored by U.S. Senator Jon Kyl (R-AZ) and supported by Security On Campus, Inc.

The Act amended the *Jacob Wetterling Crimes Against Children and Sexually Violent Offender Registration Act* to require sex offenders already required to register in a State to provide notice, as required under State law, of each institution of higher education in that State at which the person is employed, carries on a vocation, or is a student.

It requires that state procedures ensure that this registration information is promptly made available to law enforcement agencies with jurisdiction where the institutions of higher education are located and that it is entered into appropriate State records or data systems. If a college or university has a police department they must be provided with this information. These changes took effect October 28, 2002. If a state is not in full compliance by September 30, 2003 they risk loss of ten percent of their Byrne Formula Grant Program funding.

CSCPA also amended the *Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act* to require institutions of higher education to issue a statement, in addition to other disclosures required under that Act, advising the campus community where law enforcement agency information provided by a State concerning registered sex offenders who are on campus may be obtained. These changes took effect October 28, 2002 and the notice was a requirement that began with the annual Jeanne Clery Act campus security report October 1, 2003.

Lastly, the Act amended the *Family Educational Rights and Privacy Act of 1974* to clarify that nothing in that Act may be construed to prohibit an educational

institution from disclosing information provided to the institution concerning registered sex offenders; and requires the Secretary of Education to take appropriate steps to notify educational institutions that disclosure of this information is permitted. This amendment took effect on October 28, 2000.

### **MU Alcohol Policy**

The use or possession of alcoholic beverages is prohibited on all University property, except in the Presidents and Chancellor's residence. The sale, use, or possession of alcohol may be allowed in certain instances, but only by appropriate University approval and any use is subject to all legal requirements. Such places include University Alumni centers, faculty clubs, or other designated facilities, and for single events and recurring similar events in designated conference, meeting or dining facilities provided by University food service, subject to all legal requirements.

It is the responsibility of each recognized student organization to see that those in attendance at their social functions and meetings conduct themselves in accordance with MU regulations, local ordinances, state and federal laws, and the organization's national affiliation regulations. Each recognized student organization shall be held responsible, as an organization, for any violation of MU

regulations, local ordinances, state and federal laws, and the organization's national affiliation regulations committed on any premises under its control.

The University of Missouri-Columbia observes and supports all applicable state and federal laws and local ordinances regulating the sale and possession of alcoholic beverages. ### **MU Drug Policy**

The University of Missouri regulations prohibit the manufacture, use, possession, sale or distribution of alcoholic beverages or any controlled substance without the proper prescription or required license or as expressly permitted by law or University regulations, including operating a vehicle on University property, or on streets or roadways adjacent to and abutting a campus, under the influence of alcohol or a controlled substance as prohibited by law of the State of Missouri. ### **The University of Missouri Wellness Resource Center also provides the following Alcohol and Drug Abuse Prevention programs:**

#### **ADAPT**

The ADAPT (Alcohol and Drug Abuse Prevention Team) peer educators are a group of 25-30 students who volunteer to educate students and community members on a variety of issues ranging from alcohol and drug issues to stress management. Each year, the ADAPT peer educators alone present over 150 educational programs impacting more than 5000 students. The peer educators are the backbone of ADAPT's prevention efforts. They meet weekly and go through extensive training. You must go through a selection process to be chosen.

#### **GAMMA**

(Greeks Advocating the Mature Management of Alcohol) GAMMA is composed of greek students who are interested in issues related to responsible alcohol use. Representatives of many fraternities and sororities volunteer to help plan events and services for their fellow greek students.

#### **PARTY**

(Promoting Alcohol Responsibility Through You) PARTY is a campus wide student organization whose purpose is to organize campus and community activities and programs that promote responsible decision making in regard to alcohol.

### **Steering Committees**

Any interested student can also volunteer to become a member of student steering committees. The Alcohol Responsibility Month Steering Committee meets from April through October to create, plan and implement Alcohol Responsibility Month. The Wellness Month Steering Committee meets February through April to create, plan and implement Wellness Month. The steering committees meet weekly and are open to anyone.

### **Crime Prevention**

The University of Missouri-Columbia has a full time crime prevention unit that provides educational programming, security surveys, and other crime prevention functions to the university community.

One of the missions of the crime prevention unit is to educate the members of the University of Missouri community about safety. Knowing how to protect yourself and being aware of your environment are the best ways to prevent from becoming a victim. MUPD offers several programs centered on preventing crimes. All programs are free to anyone affiliated with the University and include:

### **Your Role**

A high percentage of campus crimes are incidents of opportunity. Often students contribute to situational crimes by needlessly placing themselves or their property at risk. Crime will occur wherever there is opportunity, but prevention efforts can be effective in reducing these opportunities. You play an essential role in crime

prevention efforts. Be cautious, careful, and alert to your own safety; protect your possessions and University property.

A secure environment is made possible through community involvement in crime prevention. The purpose of community crime prevention is simple: to help you recognize your own vulnerability to crime, and reduce your risk through preventive action and cooperation with the police.

Theft is the most common crime on the Columbia campus. Most thefts occur during the daylight hours, and thieves enter the structure without forced entry. In your residence, living group or office, exchange information about your schedule and watch your neighbors' rooms and work areas.

### **Non-residential Buildings**

Most non-residential campus buildings and facilities are accessible to members of the campus community and guests and visitors during normal hours of business, Monday - Friday, and for limited designated hours on Saturday and Sundays. Access times will vary depending upon the nature of the building and activity. Except for those students, faculty and staff with keys or appropriately authorized access cards, access is generally restricted to University-affiliated personnel during recognized holidays.

It is the policy of the University of Missouri-Columbia that after normal working hours, all buildings should be locked to maintain security of the buildings and their contents. Faculty, students and staff members may be issued keys to University buildings upon recommendation of the department chairman or administrative head, in accordance with established procedures. Keys are issued for entry to University buildings for conducting University business only.

### **Residence Halls**

All University residence halls have a 24-hour security program that includes many security measures.

1. Exterior doors lock electronically at 11:00 PM and the hall is then closed to the public.
2. Security devices are installed on ground floor windows and room doors have dead bolt locks and door viewers.

Residents can protect themselves and their property by responsible decisions. Unescorted persons should not be given access to residence hall after hours; residents can access their own halls after hours by "swiping" their student id card through the card reader. Doors should not be propped open at any time. The names and telephone numbers and locations of on-duty Community Advisors (CA's) are posted in the residence halls; each resident should locate this information in advance of an emergency. Keeping every room door locked at all times will deter crime, as almost every theft in a residence hall is a result of an

unsecured room or unattended belongings. Every security measure taken by the residence hall staff depends on the responsible actions of each resident for its effectiveness.

Other tips for your security include:

- ◆ Ask strangers to wait in common areas while their friends are summoned.
- ◆ Lock your room door and windows when you leave, even if only for a minute, and take your keys with you.
- ◆ Keep small valuable items out of sight, in a closed drawer, or another safe place.
- ◆ Politely offer assistance to persons in your building or residence you do not recognize. If they have legitimate business, they will appreciate your help. If they do not, ask them to leave.
- ◆ Keep your room locked when you are out during move-in. Do not leave your car unlocked when loading or unloading.
- ◆ Do not leave coats, books, or other valuable items in common areas. Keep them in your room.
- ◆ If you hear or see something suspicious, call the police immediately. Dial 911 for an emergency, or 882-7201 if it is a non-emergency.

### **Maintenance and Security of Campus Facilities**

Landscaping and outdoor lighting on campus are frequently surveyed and modified for pedestrian safety and security. Campus Facilities and Grounds Personnel trim shrubs from sidewalks, walkways, and building entrances to enhance lighting and visibility. Campus walkways are inspected regularly to ensure adequate lighting and replacement of burned-out lights. Many campus emergency telephones follow major walkways. Maps showing walkways and emergency telephones are available at MUPD.

Security Officers employed by the Police Department lock exterior doors on campus buildings each evening. These security officers also report door and security hardware operating deficiencies.

**The following information is offered in an attempt to prevent identity theft and/or offer assistance to victims of identity theft:**

### **Prevention Information:**

Guard Your Numbers - Do not give out Social Security Numbers, credit card numbers, and bank account numbers over the phone unless you initiate the call and know the person or organization on the other end. Never give this information to a stranger, even one claiming to be from your bank. Do not write your personal identification numbers (PIN) down; memorize them. Refrain from printing your social security number or credit card numbers on your checks.

Report It Immediately – If you suspect you are the victim of identity theft call the police department to report it. Also call banks to report lost or stolen checks and ATM cards, call credit card companies to notify them of stolen cards or potential fraud.

Checks - Do not leave new check orders in your mailbox for extended periods of time, and verify new deliveries are complete to assure that none have been

stolen. Store checks in a safe place: all cancelled or new checks should be stored in a safe place.

Secure Important Documents - Do not carry your social security card, passport, or birth certificate with you. Keep them in a secure area, such as a fire safe box or safe deposit box.

Banks and Credit Card Companies - Do not give account information anyone calling to 'verify a statement' or 'award a prize'. Banks and Credit Card Companies have your account information and do not need to ask you for it. Beware of fraudulent web sites and e-mails requesting personal information.

Guard Your Information - ATM personal identification numbers (PIN) and receipts are access tools for thieves. Do not write your PIN down. Keep it protected.

Mail Solicitations - Do not just throw pre-approved credit offers away. Shred them to prevent thieves from using them to assume your identify. Shred any other financial information before disposing.

Mailbox Protection - Do not leave your mail in the mailbox for pickup. Drop it in a secure, official drop box of the U.S. Postal Service. Thieves can use your mail to steal your identity.

Bills in the Mail - Be sure your bills are arriving on time. If not, contact the company to find out why the bill is delayed. Someone may have put a false change-of-address notice on you to divert your personal information to another address for his or her access.

Review Bills Carefully - If bills or statements include suspicious items, investigate them immediately to head off any possible fraud before it occurs.

Review Credit Reports - Periodically contact one of the major credit reporting companies to review your file and verify the information is correct. As part of the federal Fair Credit Reporting Act, you are entitled to an annual free credit report from each of the three nationwide consumer reporting agencies through [www.annualcreditreport.com](http://www.annualcreditreport.com) or by calling 1-877-322-8228. You can obtain a copy of your credit report at any time for a small fee through the three major credit bureaus:

## **Crime Statistics and Definitions**

The following pages contain crime statistics from the past three years. The following definitions were used in determining these crime statistics. These statistics only slightly differ from UCR crime statistics reported by the University Police Department.

These numbers reflect crimes reported to the University Police Department and numbers reported to the University Police Department by Local Law Enforcement (City of Columbia & Boone County) and campus security authorities (Student Life, Residential Life, the Athletic Department & all other campus groups.) Numbers in this report have been reviewed to reduce or eliminate any possibility of duplication.

Crimes are recorded in the calendar year they were reported. This report does not use a map to depict its campus, non-campus buildings or property, and public property areas.

**Arson:** Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

**Criminal Homicide:** Manslaughter by Negligence: The killing of another person through gross negligence. Murder and Non-negligent Manslaughter: The willful (non-negligent) killing of one human being by another.

**Robbery:** The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

**Aggravated Assault:** An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. (It is not necessary that injury result from an aggravated assault when a gun, knife, or other weapon is used which could and probably would result in serious personal injury if the crime were successfully completed.)

**Burglary:** The unlawful entry of a structure to commit a felony or a theft. For reporting purposes this definition includes: unlawful entry with intent to commit a larceny or felony; breaking and entering with intent to commit a larceny; housebreaking; safecracking; and all attempts to commit any of the aforementioned.

**Motor Vehicle Theft:** The theft or attempted theft of a motor vehicle. (Classify as motor vehicle theft all cases where automobiles are taken by persons not having lawful access even though the vehicles are later abandoned; including joyriding.)

**Weapon Law Violations:** The violation of laws or ordinances dealing with weapon offenses, regulatory in nature, such as: manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to minors; aliens possessing deadly weapons; and all attempts to commit any of the aforementioned.

**Drug Abuse Violations:** Violations of State and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, methadone); and dangerous non-narcotic drugs (barbiturates, Benzedrine).

**Liquor Law Violations:** The violation of laws or ordinances prohibiting: the manufacture, sale, transporting, furnishing, possessing of intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still; furnishing liquor to a minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; and all attempts to commit any of the aforementioned. (Drunkenness and driving under the influence are not included in this definition.)

**Sex Offenses-Forcible:** Any sexual act directed against another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent.

- A. Forcible Rape-The carnal knowledge of a person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity (or because of his/her youth).
- B. Forcible Sodomy-Oral or anal sexual intercourse with another person, forcibly and/or against that person's will; or not forcibly against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.
- C. Sexual Assault With An Object-The use of an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.
- D. Forcible Fondling-The touching of the private body parts of another person for the purpose of sexual gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental incapacity.

**Sex Offenses--Non-Forcible:** Unlawful, non-forcible sexual intercourse.

- A. Incest-Non-Forcible sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.
- B. Statutory Rape-Non-Forcible sexual intercourse with a person who is under the statutory age of consent

### **Geography definitions from the Clery Act**

#### **On Campus**

Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and Any building or property that is within or reasonably contiguous to paragraph (1) of this definition, that is owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes (such as a food or other retail vendor).

#### **A Non-Campus Building or Property**

Any building or property owned or controlled by a student organization that is officially recognized by the institution; or Any building or property owned or controlled by an institution that is used in direct support of, or in relation to, the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution.

#### **On Public Property**

All public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus, or immediately adjacent to and accessible from the campus.
